MONEY TALKS

Yesterday, the PA House passed a minimum wage bill that would raise the wage to \$15 an hour in 20 handpicked counties and \$12 elsewhere. Wages would climb yearly tied to cost-of-living hikes starting in 2029. The wage rate for tipped workers would also rise under this legislation which experts anticipate may lead to loss of hours and positions ultimately costing those very people money or jobs. After a lengthy floor debate, the final vote on the bill was 102–101, along party lines.

SUNDAY'S FAIR GAME

A bill from licensed hunter and Allegheny County State Representative *Mandy Steele* to repeal Pennsylvania's Sunday hunting ban just cleared the State House with a final vote of 131-72 vote. House Bill 1431 would let the Game Commission include Sundays in annual hunting seasons. Game Commission Director *Steve Smith* says removing the ban could give hunters more time and boost wildlife conservation efforts. Since 2019, only three Sundays a year were open to hunting, this bill aims to open them all. Other licensed hunters and State Representatives raised concerns during the floor debate on potential impacts to Pennsylvania's waterfowl population.

TAKING ANOTHER SHOT

The Democratic National Committee voted yesterday to throw out the previous vote for the vice chair positions, rescinding the win earlier this year for State Representative *Malcolm Kenyatta* and *David Hogg*. The DNC plans to redo the election, and Kenyatta is preparing another run for the position. The recission came after *Kalyn Free*, who lost the initial election, filed a challenge based on the DNC's position on gender equity for the vice chair positions. In response to the DNC's decision, Kenyatta stated, "I look forward to making my case to DNC members and our party as a whole on how we make life better and refocusing on Trump's attacks on our Constitution and working families."
