#### FAKE OUT

Just hours into a declared ceasefire, Israel accused Iran of launching two missiles into its airspace. Iran denied the claim, and both missiles were reportedly intercepted. President **Donald Trump** said both nations had violated the fragile agreement and urged Israel to halt its bombing. While leaders on all sides said the ceasefire was active, Israel resumed strikes, citing Iranian aggression. Drone attacks in Iraq and damage in Beersheba added to the chaos. With mixed signals and mounting destruction, the future of the truce remains uncertain as the conflict stretches into its twelfth day.

### FAKE ADS GET THE BOOT

Pennsylvania's House of Representatives has unanimously passed a bipartisan bill that would ban AI-generated deepfakes in political ads. The measure targets any media, like text, video, audio, or images, that falsely portrays a candidate without their consent. If enacted, violators spreading fake content within 90 days of an election could face civil court penalties. Introduced by a long list of candidates that are currently House members, the bill now heads to the State Senate. A similar Senate bill introduced in 2024 stalled in committee, but State Senator *Tracy Pennycuick* has signaled more AI-related election legislation is on the way.

### **DRONING ON**

The Pennsylvania Senate has unanimously passed Senator Wayne Langerholc's SB

468, giving PennDOT (with the Governor's green light) authority to enter into agreements with other states to advance drone tech. Backed by over a dozen major aviation and tech groups, the bill aims to boost innovation, and economic growth. Langerholc says it positions Pennsylvania as a national drone leader, supporting regional prosperity. Its next stop, the House of Representatives.

#### **GIMME SHELTER**

The Lancaster SPCA is urgently seeking foster families after its HVAC system failed Monday, leaving most of the shelter dangerously hot. While the main dog kennel still has some cooling, the rest of the building is unfit for animals or staff. All cats have been relocated due to heat sensitivity, but over 30 dogs remain.
