Today is the long-awaited Farm Show Milkshake Day! The PA Dairy Industry is hosting a press conference at 9:30am to celebrate National Dairy Month and the Dairymen's Association will be serving their famous milkshakes. The press conference and milkshakes will be held on Commonwealth Ave behind the Capitol.

#### **TURNOVER**

Senator **John Fetterman's** chief of staff, **Krysta Sinclair Juris**, is stepping down. Her departure was shared internally on Tuesday. Juris has been in the role since April of 2024. **Cabelle St. John** will be taking over the role making her the third chief of staff to serve over the past year.

#### **AI REGULATION SHOWDOWN**

Thirty Pennsylvania lawmakers have joined 260 colleagues from multiple states in urging Congress to scrap a proposal that would block states from passing their own AI laws for the next decade. In a strongly worded letter, they argued the ban would muzzle local voices and stall vital progress. State Senator *Jay Costa* and State Representative *Jesse Topper* were two of the signees who agreed that such federal overreach threatens both innovation and accountability. With bills already advancing in Harrisburg to regulate AI, state

legislators are making it clear they are not willing to be cut out of the conversation.

#### **PA'S MAKING DOUGH**

Nearly 20 Pennsylvania-based companies earned a spot on the 2025 Fortune 500 list, showcasing the state's economic muscle across industries like healthcare, steel, insurance, and chocolate. Topping the list for Pennsylvania was Cencora (IYKYK) at #10, with other major names like Comcast, PNC, Hershey, and Dick's Sporting Goods also featured. The rankings were based on company revenues, as reported in their annual 10-K filings. Nationally, Walmart, Amazon, and UnitedHealth took the top three spots.

#### **CLASS DISMISSED**

After six years under state receivership, the Harrisburg School District will officially return to local control on June 17, marking a historic first for Pennsylvania. The district had entered receivership in 2019 due to financial instability and low academic performance but has since made significant strides in restoring solvency and trust. Acting PDE Secretary **Dr. Carrie Rowe** called the exit a model of successful collaboration, while Superintendent **Dr. Benjamin Henry** noted continued work remains, especially in academics. The district now enters a five-year state monitoring phase, with its school board resuming full governance on June 24.
