#### **FAIRWAY WIN**

South Mountain Golf Course is no longer facing closure after a surge of community support pushed the state to reverse course. DCNR had planned to end the family's lease to build a visitor center, but public outcry and pressure from local lawmakers prompted the agency and the Shapiro Administration to extend the lease for ten years. The decision keeps the decades-old course open and highlights how fast a hometown favorite can rally support when its future is on the line.

### **GETTING OUT WHILE YOU CAN**

**Alina Habba**, New Jersey's top federal prosecutor and former personal attorney of President **Donald Trump**, announced her resignation as acting U.S. attorney in New Jersey. This comes as an appeals court ruled that her conduct in the position was unlawful. The Justice Department stated that they will fight this ruling with the expectation that Habba will resume her role as attorney should the appeal be successful.

## **OVERRULED**

The U.S. Supreme Court has shown signals of support for the President's decision to fire board members of federal agencies with Justices **Brett Kavanaugh** and **John Roberts** saying that the President has the right to do so. The case came as a result of the firing of Federal Trade Commission member **Rebecca Slaughter** without a given cause. However, this may have legal implications for previous firing decisions for Federal

Reserve Governor *Lisa Cook* and Library of Congress copyright official *Shira Perlmutter*.
