## SUE

U.S. Senator **Mark Kelly** (D - Arizona) is suing the Secretary of War, **Pete Hegseth**, claiming that the Pentagon's efforts to demote Kelly is unlawful. This comes after Senator Kelly and other notable veterans reminded U.S. service members to not obey any unlawful orders. Secretary Hegseth is moving to strip the Senator of his retirement rank claiming that as retired, he is still subject to the UCMJ. Senator Kelly claims that these actions violate his rights to free speech, and his rights to due process.
