PREDICTABLE

PA Attorney General **Dave Sunday** has joined a multi-state lawsuit headed by Alabama Attorney General **Steve Marshall**. They, alongside 42 other state Attorney Generals, argue that states have their own regulatory authority over prediction markets such as Kalshi and Polymarket, and have sent a letter to the Commodity Futures Trading Commission.

U.S. Representative **Brendon Boyle** (D-PA) is emerging as a potential Democratic challenger to U.S. Senator **John Fetterman** (D-PA) in the 2028 Senate race, as Fetterman faces growing criticism from some within his party. Boyle has expressed concern over what he describes as Fetterman's shifting positions on major issues. While Boyle's current focus is on winning reelection in his congressional district this year, he did not rule out a Senate bid, telling Pennsylvanians to "stay tuned" when he considers his plans in 2027.

MEET & GEEK

Philadelphia's Mütter Museum, known for its collection of unique medical specimens and historical artifacts, is offering visitors a sensory experience during its Meet & Geek event on August 13th. The lecture, titled "Sensing Illness, Then and Now," will explore the unusual methods physicians have used throughout history to diagnose diseases, including relying on scents associated with certain illnesses. FLYING AWAY

The Falconry Experience is being shut down at ZooAmerica, according to its director, **Jack Hubley**. Hershey Entertainment and Resorts, which operates the zoo, determined that traditional falconry techniques "are no longer in keeping with modern zoo standards," according to a statement Hubley posted to his Facebook account. For 18 years, the Falconry Experience allowed participants to see birds of prey in action and have them land on their gloved hands. The final day of operation for the experience will be August 31st.

Spider-Man: Brand New Day soared to a massive \$355 million domestic opening weekend, making it the second-biggest box office debut in history, trailing only Avengers: Endgame's \$357 million launch in 2019.
